July 13, 2016 Meeting Minutes

The Walker Township Recreation Board met on Wednesday, July 13, 2016 at the Walker Township Municipal Building. Present: Paul Baker, Perry Shellenberger and Nancy Baillie. Absent: Bruce Righter and Martin Dreibelbis. Paul Baker called the meeting to order at 7:00 pm.

Visitors: Brandy Meifert, Tyler Mingle, Fidel & Tabitha Lopez, Nathan Schlegel, Matt Wray (Port Royal Youth Soccer) and Ron Yorks.

The minutes of the June 8, 2016 meeting were approved as presented.

The treasurer's report – As of June 30, 2016, the treasurer reported the following: **Income:** \$4.62 (Interest), \$375.00 (pavilion/Kitchen rental), \$50 (security deposit), \$40 (dragging) and \$25 (bathroom cleaning) and Expenses: \$885.65 (Broadleaf treatment) and \$36.15 (equipment repairs). Treasurer's report was approved as presented.

Old Business: Perry has not received the prices for the slide parts and/or entire slide replacement.

New Business: June 11, 2016 – work detail consisted of 3 board members and 1 supervisor. The spring animal was fixed and 2 bases were reset (Field 1 and 2) and the split rail fence was partially fixed. June 17, 2016 – the split rail fence and water line were fixed. By motion of Perry, seconded by Nancy and carried it was resolved to purchase the key drop that Marty had researched. After researching the cost of mulch, the board will purchase the playground mulch from Blue Mountain Processors. John Henry will be contacted for an available date. It was decided to hold off on the fertilizer until rains. Mr. Yorks reported an attempted break-in at the Mexico Field. Someone tried to pry the hasp on the tractor shed. Mr. Yorks has fixed the hasp. It was mentioned that the sheds should have better security at both parks. Mr. Yorks reported 2 road signs at Walker Park were pulled out and 1 pulled over.

Coaches meeting: The coaches from Port Royal Youth Soccer were present as required for a pre-season requirement list. The trail is for walking only – no vehicles except emergency vehicles, take trash to the dumpster when 2/3 full and replace bags (located in storage sheds/concession stand), and check the bathrooms before and after practice and games. Report if there is problem.
