Walker Township Park Rules and Regulations

"The Walker Township parks are the collaborative efforts of the dedicated volunteers who have devoted their time and efforts to establishing these grounds. Your assistance, by abiding by the rules of the park, helps to maintain the park as a clean family oriented facility for all to enjoy. Thank you for your cooperation."

General

1. Township parks are open DAWN to DUSK.
2. Destruction, damage or removal of any vegetation or defacement of park property is prohibited.
3. Loading and unloading of vehicles must be done from parking lot areas. No person shall drive a motor vehicle within or upon any part of the park, recreation area, or open space.
4. All vehicles must park in designated areas. No parking on grass.
5. No off-road vehicles are allowed in park.
6. Dogs must be kept under restraint at all times by means of a leash, picked up after and properly disposed.
7. Firearms, air guns, paint ball guns, crossbows, bows and arrows and fireworks are prohibited.
8. Golfing or (practice) driving of golf balls in the park is prohibited.
9. Glass bottles and containers are prohibited.
10. No person in attendance at the park:
 - Shall bring into the facility, possess or consume any alcoholic beverages or illegal drugs of any kind; no person shall enter the park in an intoxicated state or otherwise be under the influence of alcohol or illegal drugs.
 - Shall disturb the peace by any conduct so as to annoy any other person using the park.
 - Shall use threatening, abusive, insulting, profane, or obscene language.
11. Athletic Fields must be reserved separately from Pavilion Rental. This must be done through the Walker Township office.
12. Please obey all "FIELD CLOSED" signs.
13. Any maintenance issues shall be brought to the attention of the Walker Township office.
14. All areas used must be "policed" for trash. All trash in receptacles must be placed into dumpster at conclusion of your event.
15. Bases must be returned to storage and base plugs installed.

Multipurpose Trail

1. The multipurpose trail is intended to be used for purposes of walking, and jogging.
2. No person shall operate any motor vehicle whatsoever upon or over the multipurpose trail except upon approval of Township Recreation Board.

Pavilion

1. Pavilion may be used if not reserved, however, no access will be allowed into kitchen.
2. Damage/Cleaning: A damage/cleaning fee of \$25 per hour will be charged if the following is not completed:
 - Decorations removed, including all tacks, staples, and tape;
 - Tables wiped clean and in the same place as when party entered pavilion;
 - Floors swept, debris placed in dumpsters or garbage cans, spills mopped clean (you must supply your own cleaning equipment).
 - All garbage within a 25-foot radius of the pavilion placed in dumpster or garbage cans located in the park.
3. Kitchen and restroom windows and doors must be closed and locked. All lights turned off.
4. Grills: Grills are not allowed under the pavilion.
