June 8, 2011 Meeting Minutes

The Walker Township Recreation Board met on Wednesday, June 8, 2011 at the Walker Township Municipal Building. Present: Paul Baker, Martin Dreibelbis and Nancy Baillie. Absent: Bruce Righter and Perry Shellenberger. Paul Baker called the meeting to order at 7:00 pm.

Visitors: Brian Strawser.

The minutes of the May 11, 2011 meeting were reviewed and approved.

The treasurer's report – As of May 31, 2011, the treasurer reported the following: **Income:** Interest - \$34.10 and **Expenses:** \$2,854.43 (Bldg Construction), \$508.76 (Park Supplies), \$661.95 (Fertilizer), and \$138.71 (Field improvements). Treasurer's report was approved as presented.

Old Business: 1) Signs for picnic tables were ordered, received and installed, 2) Glue traps with a box were purchased to control pests. These will need to be checked regularly, 3) the letter concerning field readiness was emailed to all coaches on May 19, 2011.

New Business: The following items were completed from May 13, 2011 to June 8, 2011: Field was over seeded and fertilized, Men's room partitions were installed, picnic tables assembled & installed, a total of 4 people from the user groups showed up for the June 4 work detail. By motion of Marty, seconded by Nancy and carried it was resolved to purchase memorial benches from Dumor (if such a request should be made). Items 57-60 PL (with a back) and 105-60 PL (backless) were chosen.

1 sign at each field will be posted with instructions on how to reserve the field for usage. They will be red and white.

Concession stand committee: The committee has not met yet this month.

Field use request: By motion of Marty, seconded by Nancy and carried it was resolved to approve Luke Storey's request for his senior project. He will be holding a soccer camp starting July 18, 2011 through July 21, 2011 from 7 am to 1 pm. He has been requested to make a donation to the park.

By motion of Marty, seconded by Nancy and carried it was resolve to approve Cierra Flasher's request for her senior project. She will be holding a cheer camp starting June 15, 2011 through June 17, 2011 from 8 am to Noon. She will make a \$2.00 per child attending donation.

By motion of Marty, seconded by Nancy and carried it was resolved to approve Brian Strawser's request for field usage from August 1, 2011 to October 15, 2011. This will be for Port Royal Youth Soccer and will encompass all fields plus the concession stand. League fees will be forth coming.
