## April 10, 2013 Meeting Minutes

The Walker Township Recreation Board met on Wednesday, April 10, 2013 at the Walker Township Municipal Building. Present: Martin Dreibelbis, Paul Baker, Perry Shellenberger, Nancy Baillie and Bruce Righter. Absent: None. Paul Baker called the meeting to order at 7:00 pm

**Visitors:** None.

The minutes of the March 13, 2013 meeting were reviewed and approved.

The treasurer's report – As of March 31, 2013, the treasurer reported the following: **Income:** Interest - \$2.22, \$900 (PR Girls), \$125 (Dressler Reunion), \$20 (donation) and **Expenses:** \$80 (Smoking designation sign), \$843.94 (diamond tex/hauling), \$160.38 (shelves). Treasurer's report was approved as presented.

**Old Business:** “No smoking” signs were ordered, purchased and installed. \$150 refunded to Port Royal Girls Softball due to overpayment. They have 5 teams not 6. Mr. Owens reserved the softball fields for April 27 and 28, 2013. He has only 2 teams playing at this point. He will make a decision next week to cancel or play. He will contact Perry, who will then contact the concession stand committee, as they are to open the concession stand for the tournament.

**New Business:** John Henry will contact Marty when the aerator will be available for a weekend. Marty will then send out an email asking for volunteers.

Keys were given to the girl's softball coaches.

Water Samples were taken March 26<sup>th</sup> for the 1<sup>st</sup> qtr 2013 test and April 2<sup>nd</sup> for the 2<sup>nd</sup> qtr 2013 test. The water system was charged on April 6, 2013. Bathrooms are open. Sue Prye has been contacted concerning the cleaning of the bathrooms. The park's port-a-pot was removed on April 8, 2013. On April 4<sup>th</sup>, fields 1 and 2 were cleaned up; field 3 was done on April 9<sup>th</sup>.

Soil tests were taken and mailed. The results were received. Marty will contact a company concerning the correct amounts of fertilizer, etc needed as stated by the results.

**Concession stand committee:** This committee met on March 20, 2013. The committee consists of Sue Clark (president), Tiffany Lehman (Vice President), Teresa Kepner (Asst VP), Mike McCahren (treasurer), Angela Laub (secretary), and Perry and Chris Shellenberger (guidance facilitators).
