The treasurer's report – As of May 31, 2014, the treasurer reported the following: **Income:** \$3.18 (Interest), \$100.00 (Security Deposits), \$175.00 (Kitchen/Pavilion Rentals) and .53 (prompt pmt discount) and **Expenses:** \$54.53 (Supplies), \$26.54 (Light repairs), \$654.36 (fertilizer) and \$50.00 (1st/2nd qtr 2014 water test). Treasurer's report was approved as presented.

Old Business: Mr. Dave Glick replaced the bottom panel of the overhead door on field 2's shed. By motion of Marty, seconded by Perry and carried it was resolved to apply fertilizer (10-10-10) to the Mexico Field in the summer and fall of this year.
