August 13, 2014 Meeting Minutes

The Walker Township Recreation Board met on Wednesday, August 13, 2014 at the Walker Township Municipal Building. Present: Paul Baker, Martin Dreibelbis, Bruce Righter and Nancy Baillie. Absent: Perry Shellenberger. Paul Baker called the regular meeting to order at 7:00 pm.

Visitors: Melissa Graybill, Lewis Foltz, Mike Meifert, Jodi Fitzgerald, Jake Freed, Rich Rush, Erin Derr, David Portzline (Port Royal Youth Soccer), Teresa Kepner (Juniata Co Little League) and Tiffany Lehman (Mexico Youth Baseball).

The minutes of the July 9, 2014 meeting were approved as presented.

The treasurer's report – As of July 31, 2014, the treasurer reported the following: **Income:** \$2.99 (Interest) and **Expenses:** \$112.86 (supplies), and \$28.39 (Weed spray). Treasurer's report was approved as presented.

Old Business: The sprayer in the kitchen seems to be working. Sue Prye will try to clean the grease spots on the cabinets – possibility for next year – old table cloth or plastic covering to cover the cabinets when frying.

New Business: The coaches for Port Royal Soccer were present. Discussion as to what is expected of them went as follows: empty trash cans when 2/3 full, check bathrooms before and after practice and games, break boxes down before putting them in the dumpster, all vehicles to stay off trail and grass, and make sure concession stand is clean after each game.

Teresa Kepner and Tiffany Lehman were present to discuss the Mexico Field and what can be done to prevent run-off. Also, the old concession stand is in bad shape. They wanted to know if a new one could be purchased. It was suggested a meeting between the rec board members, township supervisors and Juniata County Little League be requested.

July 10th – Paul and Marty met with Austin at the Mexico field and repaired the fence, July 23th Marty worked on the fields at Walker Township Park, July 25th Austin and Marty worked on the fields. (Condition of the fields prior to the tournament were unplayable – after considerable time by Marty and Austin the fields were playable), July 24th, 25th, 26th and 28th issues with the toilet flushing were being repaired (fixed on the 28th), July 25th lime was spread, July 26th – Mr. Peterson shot grades at the Mexico field with Marty and Paul.

The 2nd base anchor on field 1 was completely destroyed and needs to be replaced.
