April 8, 2015 Meeting Minutes

The Walker Township Recreation Board met on Wednesday, April 8, 2015 at the Walker Township Municipal Building. Present: Martin Dreibelbis, Nancy Baillie and Perry Shellenberger. Absent: Paul Baker and Bruce Righter. Perry Shellenberger called the meeting to order at 7:00 pm.

Visitors: Matt Fornwalt, Jennifer Hutchinson, Tiffany Lehman, Teresa Kepner, Wade Druckenmiller and Ken Berry.

The minutes of the March 11, 2015 meeting were approved.

The treasurer's report – As of March 31, 2015, the treasurer reported the following: **Income:** \$4.14 (Interest), and **Expenses:** \$616.34 (Light repairs). Treasurer's report was approved as presented.

Old Business: None presented.

New Business: Visitors are coaches/board members for Juniata Co Little League/ Mexico Youth Baseball. Things discussed with them included: looking for help with the park, check the restrooms before and after practices/games, empty trash cans when 2/3 full and replace bags and use the grill away from the pavilion and children.

March 24 – 1st quarter water sample was taken, April 7 – 2nd quarter water sample was taken, and Field 3 gate was partially repaired and the water system was charged. All 4 pole lights and the restroom lights were repaired. A request for reduction in per team field use was denied. The policy of \$150 per team was discussed and it was decided to stay with the policy.

Keystone Lawn Treatments, LLC – wants to put a sign on the building in lieu of a labor and equipment charge. The park would pay for only the chemicals. Marty will research.

During the spring playground inspection, Perry noted the tube slide has a broken piece. He will research all options for correcting the problem.

Construction of 3 new pavilions was a topic of discussion. Sometimes people just want to use the picnic tables and if there is a game or family event this isn't a possibility. Discussion on placement: by the proposed basketball court, by field 2 and field 3.

Concession Stand Committee: No report.

Field use request: By motion of Perry, seconded by Marty and carried it was resolved to approve Juniata Co Little League's request for the Mexico Field from March 30, 2015 to August 2, 2015.

By motion of Perry, seconded by Marty and carried it was resolved to approve Kurtis Wagner's (Thompsontown Baptist Church) request for Vision Soccer Camp July 20 – July 24, 2015 from 6 pm to 9 pm. Pavilion/Field 1 and 2.

By motion of Marty, seconded by Perry and carried it was resolved to approve Deb Weber's request for July 12, 2015 from 4 pm to 8 pm. Kitchen/Pavilion

By motion of Marty, seconded by Perry and carried it was resolved to approve Jim Sherwood's request for May 10, 2015 at 3:30 pm to 8 pm. Kitchen/Pavilion.
