## March 9, 2016 Meeting Minutes

The minutes of the February 10, 2016 meeting were approved.

The treasurer's report – As of February 29, 2016, the treasurer reported the following: **Income:** \$4.67 (Interest), \$2,891.00 (Gray's Pallets donation) and **Expenses:** none. Treasurer's report was approved as presented.

**New Business: Coaches Meeting:** Marty went over the budget and expenses of the both parks.
