June 8, 2016 Meeting Minutes

The Walker Township Recreation Board met on Wednesday, June 8, 2016 at the Walker Township Municipal Building. Present: Paul Baker, Perry Shellenberger, Nancy Baillie and Martin Dreibelbis. Absent: Bruce Righter. Paul Baker called the meeting to order at 7:00 pm.

Visitors: None.

The minutes of the May 11, 2016 meeting were approved with the following correction: Perry, not Bruce, brought up the discussion of a donation box to be placed at the park.

The treasurer's report – As of May 31, 2016, the treasurer reported the following: **Income:** \$4.50 (Interest), \$375.00 (pavilion/Kitchen rental) and **Expenses:** \$20.62 (Mexico Concession stand), \$120.00 (water test 4 mths). Treasurer's report was approved as presented.

Old Business: Perry has not received the prices for the slide parts and/or entire slide replacement.

New Business: A work detail will be held on June 11 to work on the spring animal in the playground and reset the bases on the fields, repair the split rail fence, fix the water line and seed bare areas. Mexico Youth Baseball requested permission to purchase 2' by 2' signs to be placed behind home plate. The sign is dedicated to "The Greatest Ballplayer." The Board agreed with the following modifications – change "baseball players" to "ball players" or just "players" as there are different players using the fields. Also, should be "provided" or "presented" by Mexico Youth Baseball. Nancy requested a key drop box be placed by the kitchen so users may put the key in the box instead of waiting for her to come to the park. By motion of Perry, seconded by Marty and carried it was resolved to install the box.
