August 10, 2016 Meeting Minutes

The Walker Township Recreation Board met on Wednesday, August 10, 2016 at the Walker Township Municipal Building. Present: Paul Baker, Martin Dreibelbis and Nancy Baillie. Absent: Bruce Righter and Perry Shellenberger. Paul Baker called the meeting to order at 7:00 pm.

The minutes of the July 13, 2016 meeting were approved with the following corrections: Ron Yorks – Visitor and the mulch will be purchased from Blue Mountain Processors not Tuscarora Hardwoods.

The treasurer's report – As of July 31, 2016, the treasurer reported the following: **Income:** \$4.54 (Interest) and \$2,050 (field rentals) and Expenses: \$30.85 (Mexico Concession Stand) and \$69.18 (equipment repairs). Treasurer's report was approved as presented.

New Business: Marty noted 2 more split rails were missing from the fence. Fertilizer will be spread this fall. Mulch for the playground might be placed on Sept. 3, 2016.
