June 14, 2017 Meeting Minutes

The Walker Township Recreation Board met on Wednesday, June 14, 2017 at the Walker Township Municipal Building. Present: Martin Dreibelbis, Paul Baker, Perry Shellenberger, Ron Yorks and Nancy Baillie. Absent: None. Paul Baker called the meeting to order at 7:00 pm.

Visitors: Brandy Meifert (Port Royal Soccer) and Brian Strawser (JHS Soccer).

The minutes of the May 10, 2017 meeting were approved as presented.

The treasurer's report – As of May 31, 2017, the treasurer reported the following: **Income:** \$1.90 (Interest), \$225 (Field/Kitchen rentals), \$450 (Field – Juniata Co LL). and **Expenses:** \$8.35 (supplies), \$5,667.31 (pavilions). Treasurer's report was approved as presented.

Old Business: The barrier for the playground system was discussed. Perry is trying to come up with a solution.

PAVILIONS: ceilings were installed, wiring was done in both the pavilions and tractor shed, and passed the final inspection.

7 telephone poles were received from PP&L and Steve Reinford. Marty and Ron will determine placing of said poles. Brandy Meifert and Brian Strawser were present to discuss the upcoming soccer season. The high school and junior high boy teams will need a place to practice and play a few home games due to construction. Discussion ensued concerning the logistics of working both JHS/TJHS and Port Royal Soccer working together during the season. Mr. Strawser had a few of the home games to place on the calendar. Mrs. Meifert stated Port Royal will be able to work with Mr. Strawser. Port Royal Soccer will be handling the concession stand for all games.
