## September 13, 2017 Meeting Minutes

The Walker Township Recreation Board met on Wednesday, September 13, 2017 at the Walker Township Municipal Building. Present: Martin Dreibelbis, Paul Baker, Ron Yorks, Perry Shellenberger and Nancy Baillie. Absent: None. Paul Baker called the meeting to order at 7:00 pm.

Visitors: Mark Stoicheff.

The minutes of the August 9, 2017 meeting were approved as presented.

The treasurer's report – As of August 31, 2017, the treasurer reported the following: **Income:** \$1.19 (Interest), \$250 (Pavilion/Kitchen rentals) and **Expenses:** \$13.96 (Lewistown paper). Treasurer's report was approved as presented.

**Old Business:** None presented.

**New Business:** The Aug. 12, 2017 church tournament was cancelled due to the weather.

Concerning the concession stand – a new rule will be in place. By motion of Perry, seconded by Marty and carried it was resolved that the concession stand will be cleaned out (cabinets, refrigerators, etc) within 2 weeks of the current seasons end or the Recreation Board will dispose of the items left.

The Juniata Co Teeners are playing in McAlisterville this fall but did not tell the Rec Board. Next year the electric will be shut off 2 weeks after spring ball games are completed.

The Supervisors received a letter from the County Commissioners concerning the Legacy Fund. We will be applying for \$3,600 for the 2 years (2016 and 2017). The County Commissioners, also, have a onetime grant in the amount of \$10,000 for a qualified project. The Rec Board decided to apply for the half court basketball court. Deadline is December 31, 2017. Top soil will be spread around the pavilions then seeded by John Henry.
